Internship

- > The Head of the Department suggested that a maximum of 3 months of Peripheral Postings (other hospitals) and 9 month of Postings in the Parent institution may be adopted. Other members had a divided opinion. Some of the members suggested 6 months of Internal & 6 month of External Postings (Optional).
- > The students also be permitted to go for observation training in other hospitals for a maximum period of one month in 2nd year and one month in 3rd year.
- > The Dean of AHS suggested that the mandatory period of internship in the parent institution shall be 6 months and the duration of training in other recognized hospitals (External) can be decided by the HOD concerned based on the facility available in house and the need for wider exposure.
